**Liability Release Agreement**

**In consideration of being allowed to use the Wakeboard Equipment (Wakeboard, Bindings or Rope) I agree as follows:**

(INITIAL \_\_\_\_\_) I understand and am aware that wakeboarding can be a HAZARDOUS activity. I understand that the sport of wakeboarding and the use of wakeboard equipment involve a serious risk of injury, including permanent disability or death, to any and all body parts. **I herby agree to freely and expressly assume and accept any and all risks of injury to me while using this wakeboard equipment.**

(INITIAL \_\_\_\_\_) (Bindings use only) I understand that the wakeboard equipment being used includes a binding system which will NOT RELEASE at all times or under all circumstances and that it is not possible to predict every situation in which it will or will not release, and that it's use cannot guarantee my safety or freedom from injury while using the wakeboard equipment.

In consideration of Participant, or the minor for whom the parent or guardian is signing, being allowed to participate in any way in Wake Fest (Wakefest LLC athletics/sports program and related events and activities), the Participant herby, for himself/herself, his/hers heirs, and successors and, if applicable, for the minor for whom a parent or guardian is signing does:

1. Agree that prior to participating, Participant will inspect the facilities and equipment to be used, including Participant's own equipment, and if Participant believes anything is unsafe, Participant will immediately advise a tournament official, in writing, of such condition(s) and refuse to participate.
2. Acknowledge and completely understand that each participant will be engaging in activities that involve risk or serious injury, including permanent disability or death, and severe social and economic losses which might result not only from Participant's own actions, inaction's or negligence, and also from the actions, inaction's or negligence of others, the rules of play, or the condition of the premises or of any equipment used. Further, that there may be other risks not know to Wakefest LLC or not reasonably for reseable at this time.
3. Assume all the foregoing risks and accept personal responsibility for the damages following such injury, permanent disability or death.
4. Release, waive, discharge, covenant not to sue and agree to indemnify, hold harmless and defend, Wakefest LLC, their affiliated clubs or other affiliated organizations, their respective administrators, directs, agents, coaches, and employees, other participants, sponsoring agencies, sponsors, advertisers, the national governing bodies of the participating divisions and tournaments, the tournament officials and if applicable, owner and leases of premises used to conduct the event. All of which are hereinafter referred to as "releases", from any and all liability to Participant, his or her heirs, relatives and friends for any and all claims, demands, losses or damages on account of injury to person, including death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releases or otherwise.
5. Authorize Wakefest LLC to seek, on Participant's behalf all reasonable medical and surgical care that might be necessary if Participant is unable to authorize such care himself/herself as a result of some injury.
6. Agree that the Organizers have the right to control or prohibit advertising material used, worn, or displayed by me at the site during the tournament. Participant, or the minor for whom a parent or guardian is signing, further understands Wakefest LLC reserves the right to disqualify Participant and to refuse to allow Participant to compete in the tournament for any reason that Wakefest LLC deems just and proper, and in such event Participant will be entitled to the return of his/her entry fee and no more.
